#### PAWF International Wushu Judges Training & Certification Course

#### GENERAL INFORMATION

The PAWF will hold the first English & Spanish International Wushu Judges Training & Certification Course in Lubbock, TX starting May 23rd, 2022. The purpose of this course is to offer participants technical training in their native language. All PAWF member federations are eligible to submit participants to the courses according to the stipulations within these regulations.

#### A. DATE AND PLACE

The PAWF International Wushu Judges Training & Certification Course will be held for 4 days from Monday, May 23rd to Thursday, May 26th, 2022 at the MCM Elegante Hotel and Suites in Lubbock, TX.

#### C. ELIGIBILITY OF PARTICIPANTS

- 1. All participants should be in good physical health.
- 2. All participants must be fluent in either English or Spanish languages.
  - The lecture and testing material for this PAWF Judges Course will be available in Spanish but PAWF and IWUF official languages remain English and Chinese.
- 3. All participants may only be approved to the course by their respective PAWF Member Federation/Associations.
- 4. All participants must be legal residents of the countries/territories which are submitting them.

#### D. ENTRIES

#### **Final Entries**

All final entries must be submitted through the PAWF Online Registration System. All sections of the online entry must be completed in full. Each group is required to print a copy of the submitted entry and present it upon arrival and registration at the respective course. The

deadlines for the final entry to be completed through the online system for the course is as follows:

#### E. ARRIVAL & REGISTRATION

1. All participants are required to check in with the Organizing Committee at the 2022 PAWF Judges Course Registration Desk at the MCM Elegante Hotel and Suites in Lubbock, Texas no later than 24:00 (Central Time) on May 26th.

2. Upon arrival, all participants are required to pay the relevant participation fees in full.

#### F. CERTIFICATION

- 1. All new participants that pass the examinations will be certified as A grade Pan American Wushu taolu or sanda judges and awarded the relevant judge certification and badges.
- 2. All existing judges which pass the examinations will receive their grade based upon the requirements set out by the PAWF Technical Committee and be awarded the relevant judges certification and badges.
- 3. Those participants who fail to pass the relevant examinations will only receive certificates of participation.

#### G. FINANCIAL CONDITIONS

- 1. The participation fees are as follows:
  - Taolu Course \$495
  - Sanda Course \$345
- 2. The international airfare and related travel expenses, as well as accommodations and participation fees shall be borne by the teams themselves.
- 3. The participating teams shall pay their full participation fee to the Organizing Committee of the 2022 PAWF International Wushu Judges Course upon arrival & registration.
- 4. Participants are responsible for their own accommodations, transportation and meals. The main hotel (MCM Elegante Hotel and Suites) has a free shuttle to the airport.

#### H. OTHER MATTERS

1. All participants are required to abide by the conditions stipulated by the PAWF and the organizing committee. The PAWF reserves the right to deny participation in the course to those participants who fail to abide by the aforementioned conditions. All costs related to this shall be borne by the participants/federations themselves.

o Taolu: Grade B; Grade A

o Sanda: Grade B; Grade A

- 2. Taolu Examination Course Participants
  - Technical Examinations
    - i. All participants are required to perform 1 bare hand and 1 weapon routine from the following list:

- ii. If deemed necessary, the PAWF Technical Committee may require a participant to perform only half of their selected routine. In such cases, whether the participant performs the first half or the second half of their selected routine, will be determined by drawing random lots.
- iii. Note: the 1<sup>st</sup> or 3<sup>rd</sup> set compulsory routines must be learnt by the candidates themselves prior to arrival, the instructional videos may be found at <a href="https://www.youtube.com/user/iwufwushu">https://www.youtube.com/user/iwufwushu</a>
